Your Radio Frequency Request

Most skippers are using 2.4 GHz radios these days. For those who are not you will need to bring a minimum of three (3) crystals for your radio. This is important to avoid the possibility of sharing crystals. Hint: Bring your own. Note: AM modulated radio gear is not recommended in 75 and 50MHz. Dual Conversion is the majority. Use of AM in those bands could lead to radio conflicts.
