September 24-26, 2010

Location: The regatta will be held at Century Park, Big Bear Lake, Vernon Hills, Illinois – 36 miles NNW of Chicago.

Rules: The regatta will be governed by the current edition of the Racing Rules of Sailing, as modified by Appendix E, the Sailing Instructions and the current “J” Class Rules.

Eligibility: The regatta is open to all boats of the “J” Class, whose owners are current members of AMYA and properly registered with the Class. Other entrants/skippers may be invited consistent with AMYA Guidelines and objectives.

Entry: Eligible boats may be entered by completing the attached official Entry Form – to be sent to Bob Armbruster prior September 18, 2010 together with the Entry Fee and address, as indicated on the form. To be eligible for frequency assignment, the Entry Form must indicate at least three (3) available frequencies for each boat entered or indicate a 2.4GHz radio.

Schedule of Events: Registration and measurement will be at the Sailing Site on Friday, September 24, 2010, as of 12:00 noon. The lake will be available for practice racing Friday after 12:00 noon.

The regatta will begin on Saturday, September 25 and continue through Sunday, September 26, 2010. Following a 9:30 AM skipper’s meeting, racing will begin each day at 10:00 AM - with the last race beginning no later than 4:00 PM on Saturday and 2:00 PM on Sunday. Awards will be presented following the conclusion of racing on Sunday.

Lunch: Refreshments and lunch will be provided each day.

Sailing Instructions & Frequency Assignments: A copy of the Sailing Instructions and Frequency Assignments will be posted on our website www.chicago-rc-model-yacht-club.org after the close of entries

Racing Format: Considering weather, course and equipment conditions, racing will be conducted under the Single Fleet or Odd/Even Heat Management System. To constitute the regatta, eight races must be completed.

Scoring: The regatta will be scored in accordance with the Low-Point Scoring System, as set forth in Appendix A of the Racing Rules of Sailing, using one point as the lowest score. For each eight races sailed, one high score will be discarded from the entry's overall score.

Prizes: Trophies and Gold Chevrons will be awarded to the top three (3) finishers in the regatta.

Measurement: Measurement and class authentication verification may be conducted on site on a random basis, as determined by the Regatta Director during Check-in and Registration. A tank for water-line measuring will be made available for "statistical purposes" to any owner/skipper upon demand.

Accommodations: The Holiday Inn Express, 975 North Lake View Parkway, Vernon Hills, IL – phone 1/847-367-8031 – will be the Head Quarter for this event, as it is conveniently located across the street from the Sailing Site.

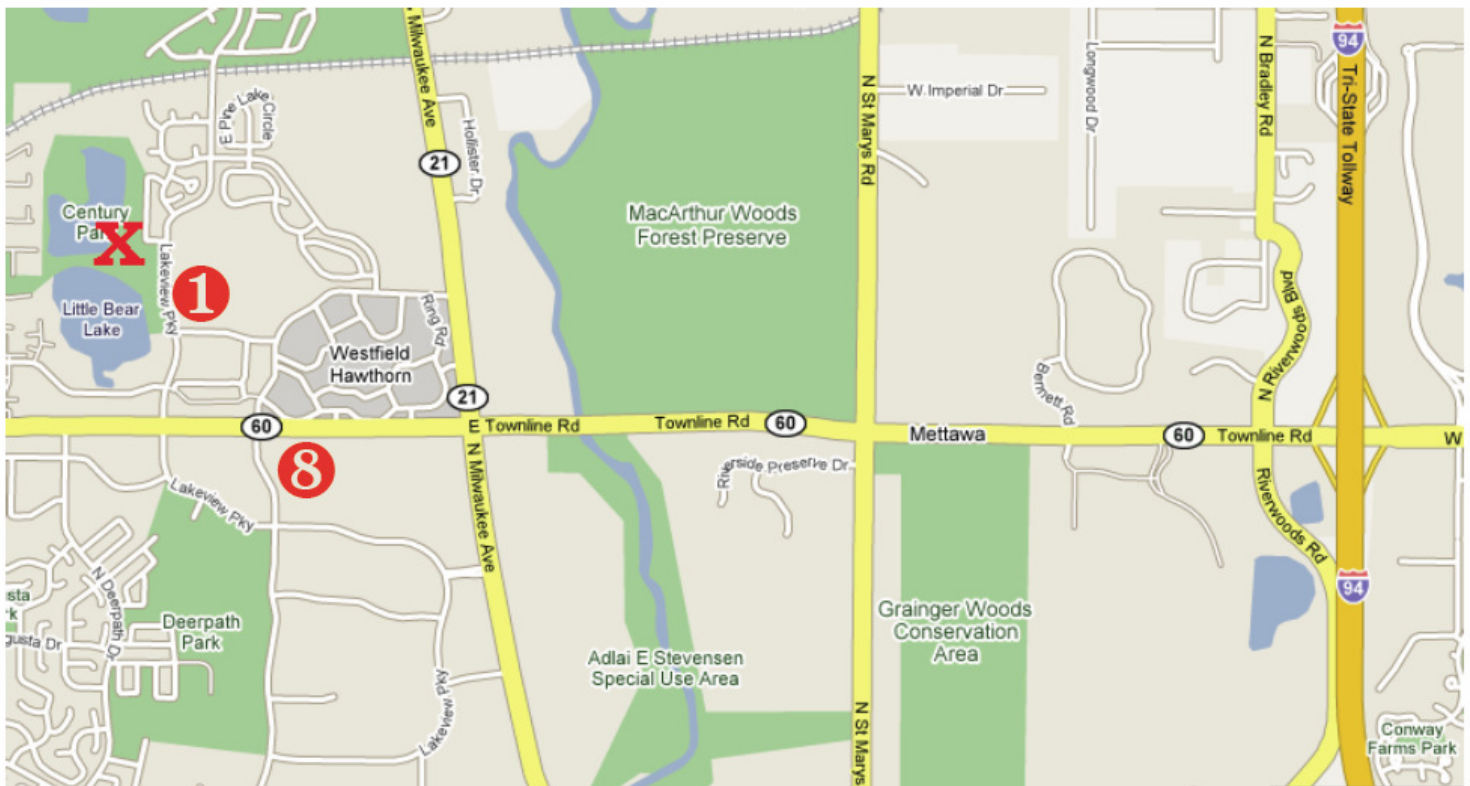
