Eligibility: The Regatta is open to all class legal and properly registered EC-12 yachts.

Rules: The rules will be governed by the current Racing Rules of Sailing (RRS) as modified by Appendix E, the prescriptions of US Sailing when they apply, the rules of the EC-12 Class and the Sailing Instructions.

Location: James Island County Park 871 Riverland Dr. Charleston, SC 29412

Entry: Eligible boats will be entered after the completed attached form and entry fee is mailed and received **no later than December 6th**. The entry fee is \$35.00 and includes coffee/donuts, drinks and lunch Saturday. Guest lunches are an additional \$7.00.

Scoring: The Low Point Scoring System as set forth by Appendix A of the RRS will apply.

Prizes: Trophies will be awarded to the top four skippers.
